



## **Mailing List Order Rental Information**

APsAA provides mailing list for the purpose of promoting education or scientific courses, seminars, meetings, recruitment, books or products concerned with psychoanalysis, psychology, or mental health.

1. APsAA grants Licensee a nonexclusive, nonassignable license to use APsAA's mailing list for a single mailing. The license is for one-time only and only for the purpose of mailing the materials provided to APsAA.
2. Licensee agrees not to disclose, transfer, duplicate, alter or reproduce any portion of the list in any form, including entry into electronic databases. Licensee agrees to destroy the mailing list (in whatever form) after Licensee's one-time use.
3. Licensee agrees that APsAA has the right to monitor the use of the mailing list.
4. Licensee must submit a sample mailing(s) to APsAA for review prior to fulfilling the list order. APsAA has the right, in its sole discretion, to reject any order.
5. Licensee acknowledges that the granted license does not constitute APsAA's endorsement or approval of Licensee's goods or services and Licensee agrees not to communicate an endorsement or approval. Licensee agrees that APsAA's name or logo will not be used on the Licensee's mailing, without APsAA's prior written approval.
6. Licensee shall indemnify and hold harmless APsAA, its officers, directors, employees, members, and agents, and each of them, from and against any and all actions, claims, losses, demands, costs (including attorney's fees), and all other expenses arising directly or indirectly from Licensee's use of the emailed, computer diskette, or paper labels or any name or address listed therein.
