1. Call to Order and Opening Remarks – Dr. William C. Glover

The meeting was called to order at 11:03 am eastern time. Dr. Glover welcomed everyone and introduced the members of the Executive Committee and guests.

2. Secretary's Report - Dr. Bonnie Buchele

A. Roll Call

Given the limited time, Dr. Buchele asked that Staff confirm the names of Executive Council members present who were entitled to vote, thus establishing a quorum.

B. Approval of Agenda

Upon motion duly made and seconded, the agenda for the meeting was adopted.

C. Notice of Proxies

Dr. Buchele reported that 309 proxies were received for the Meeting of Members on Thursday, June 18, 2020.

D. Approval of Minutes of February 13, 2020, Executive Council Meeting
The chair asked for corrections to minutes of the February 13, 2020, Executive Council
meeting which were posted online on March 23, 2020. Since there were no corrections, the
Minutes were approved as written.

E. Membership Update

The Association has 2,966 members. By category, there are:

- 1,134 Active Members
- 1,310 Senior / Life Members
 - 465 Candidate Members
 - 25 Academic Associate Candidates (non-voting)
 - 32 Academic Associates (non-voting)

Since the February Meeting, the following changes in membership have occurred:

- 71 Active Members became Senior Members
- 20 members have died
- 5 members have resigned
- 1 Candidate Member was dropped because he/she is no longer a candidate in training.
- 5 members reinstated their membership
- We gained 58 new Actives and 55 Candidate Members

In addition, we had the following new members join since the February Meeting:

- 17 New Candidate Members
- 1 New Academic Associate Candidate (non-voting)

Effective at this meeting, we will have the following new members:

- 12 Candidate Members graduated and will automatically become Active Members
- 14 graduates of institutes that are not APsaA institutes will become Active Members
- 1 IPA member or IPA graduate will become an Active Member

The current June 2020 Associate totals:

- 50 Educator Associates
- 281 Psychotherapist Associates
- 21 Psychotherapist Associate Trainees
- 34 Research Associates
- 142 Student/Resident Associates

F. Summary of Actions of Executive Committee Meetings

During the period between the February 2020 Executive Council meeting and this meeting of the Executive Council, the Executive Committee took the following actions:

I. Strategic Advisory Committee

The Executive Committee appointed a Strategic Advisory Committee to oversee implementation of the strategic goals.

II. Budget Priorities

The Executive Committee unanimously approved a statement outlining organizational priorities during the COVID-19 pandemic.

III. COVID-19 Advisory Team

The Executive Committee endorsed the creation of the COVID-19 Advisory Team, cochaired by Todd Essig, M.D. and David Scharff, M.D.

IV. Surveys

Given the global COVID-19 crisis, the Executive Committee agreed to postpone the circulation of all surveys, including the TA/SA Survey to the membership until a more appropriate time.

V. June Meeting

The Executive Committee cancelled the in-person June meeting, planning instead to have it in a virtual format.

VI. TAP

The committee endorsed the appointment of Lyn Yonack, M.S.W., as the new TAP Editor.

VII. Executive Committee Meeting Registration Fees

The Executive Committee Members voted to pay their own registration fees to the virtual meeting in the interest of pandemic budgetary concerns.

VIII. Antiracism Advisory Group

The Executive Committee created the Antiracism Advisory Group.

IX. TA/SA Task Force Survey

The Executive Committee agreed with the decision of the TA/SA Task Force to release the TA/SA survey on Monday, June 22. Results will likely be available by October 2020.

3. Membership Requirements & Review Committee (MRRC) – Dr. William C. Glover

The Membership Requirements & Review Committee (MRRC) met via zoom and approved 1 application from an IPA member or IPA graduate, and 14 applications from graduates of APsaA-approved institutes who had never joined APsaA.

4. Institute Requirements & Review Committee (IRRC) - Dr. William C. Glover

At the February 2020 meeting of the Executive Council, the IRRC recommended a proposed clarification regarding the definition of "a portion" as written in the current APsaA Standards for Education, Section IV(A) in reference to a candidate's analysis. A motion to refer the proposed "portion" language back to the IRRC for further discussion as well as consideration of a friendly amendment offered by Prudy Gouguechon, M.D., was approved.

During discussion at its meeting in June 2020, the Executive Council considered and approved further modifications to the newly proposed language by unanimous consent, and ratified the proposed revisions to the Standards for Psychoanalytic Education, Section IV(A):

A non-reporting analysis is defined as completely confidential, without any participation by the candidate's analyst in progression decisions. APsaA's educational model allows for modifications of the frame, as necessary, including changes in frequency, the use of the couch, and remote or condensed analysis. The Education Committee or equivalent committee of a local institute may permit a candidate's analysis to be conducted via telephone or other electronic means on a regular basis when distance sessions are necessary for an analysis to occur or to provide a greater choice of analyst. In some analyses many sessions, or on occasion even all sessions, may need to be by telephone or electronic means. Condensed analysis with more than one session per day may also be permitted, as necessary. The Training and Education Section of the DPE is available for consultation. The local institute may choose to waive the requirement for analysis by a Training Analyst (TA) when the candidate is in an ongoing psychoanalytic treatment with a graduate analyst who is not a TA. Suggested guidelines for this modification will be discussed later in this document (Section VIII, C and E). The candidate must be in analysis for a substantial period of time that overlaps with supervised analytic casework.

The IRRC also proposed changes throughout the Standards document where a gender requirement is mentioned. Modifying the requirement addresses the need to integrate the importance of examining one's preconceptions about sex and gender throughout the curriculum, including the realization of some gender fluidity in all individuals, but to avoid privileging gender diversity over all other types of diversity. The intent is to help candidates develop an analytic attitude that every patient is diverse in many ways, not just regarding gender.

The proposed revisions will be circulated to the members for comment over a period of at least 90 days prior to final approval.

5. Advocacy, Public Information and Branding Task Force

The Executive Council unanimously approved the newly created Task Force on Advocacy, Public Information and Branding to help coordinate efforts related to public information,

advocacy, branding and overall APsaA messaging within the goals of organizational strategic planning and the budget. The members of the task force include: Ben Herbstman, M.D., MHS (Chair), Brenda Bauer, Psy.D., Julio Caldron, M.D., Jack Drescher, M.D., Sue Kolod, Ph.D., Flora Lazar Ph.D., Austin Ratner, M.D., Jonathon Shedler, Ph.D. and Mark Smaller, Ph.D. The hope is that the committee could provide a preliminary report for the February 2021 meeting

6. Treasurer's Report - Dr. Bill Myerson

Dr. Myerson presented his final report to the members of the Executive Council after serving three consecutive terms (from June 2011-June 2020) as the Association's Treasurer. He presented the proposed FY 2021 budget, outlining the process by which the budget was prepared, and noted that the Association continues to move towards improved financial stability. He recommended continued exploration into the selection of a new auditing firm, and giving consideration to procuring someone to actively manage the Association funds.

The Executive Council considered an appeal by Dr. Smaller to reconsider approving the Public Advocacy Department's proposed budget of \$45,000 in support of ongoing lobbying efforts. Several committee chairs with budgets that were also decreased, spoke to the issue.

After full discussion, a motion to increase the Public Advocacy Department's budget to \$45,000, with a review of future budget funding following the completion of the current work of lobbying efforts in February, 2021, was not approved.

Upon motion duly made and seconded, the proposed FY 2021 budget was unanimously approved as presented.

Dr. Myerson thanked the members of the Executive Council and the APsaA Staff for their continued support during his term of service. He was presented with a certificate in appreciation for his service.

7. Addressing Racism Statement

Given the current racial tensions in the US, with specific focus on internalized racism, the Executive Council approved the adoption of a proposed statement on racism, including recommendations outlining strategies in support of its members in combating racism. The newly created Anti-Racism Advisory Group, chaired by Anton Hart, Ph.D., will review current organizational practices and policies with regards to race and make recommendations so that psychoanalytic organizational best practices, education and training are improved. It is hoped that ongoing conversations regarding racism will strengthen APsaA, its members and communities. The Executive Committee will also engage a consultant to help in these efforts.

8. Executive Session: Council Elections

The business of nominations and elections for Officers, Executive Committee members and various Council Committee positions was held in Executive Session.
