- (2) The theoretical basis of all books and articles included will be exclusively or mainly psychoanalytic.
- (3) New entries will be sought in journals having a recognized psychoanalytic focus.
- (4) All included items are judged as making some original clinical and/or theoretical contribution to the psychoanalytic understanding and/or treatment of autism spectrum disorders.
- (5) All items included have been read and evaluated for their appropriateness by at least one member of the APsA DPE ASD Committee.

The criterion for items included in the “Ancillary Readings” in part (C) is that although the item may not have a primarily psychoanalytic basis, it is deemed by the ASD Committee to be directly relevant to the work of the Committee.
