

Mailing List Order Rental Information

- 3. Licensee agrees that APsA has the right to monitor the use of the mailing list.
- 4. Licensee must submit a sample mailing(s) to APsA for review prior to fulfilling the list order. APsA has the right, in its sole discretion, to reject any order.
- 5. Licensee acknowledges that the granted license does not constitute APsA's endorsement or approval of Licensee's goods or services and Licensee agrees not to communicate an endorsement or approval. Licensee agrees that APsA's name or logo will not be used on the Licensee's mailing, without APsA's prior written approval.
- 6.
